

Code of Conduct

Belarusian Festival (“Festival”) organized by BelFestTexas, a Texas not for profit corporation, and its representatives (“Festival Organizers”), will take place September 16-18, 2022 at the Mystic Quarry Camping Grounds in Canyon Lake, Texas (“Premises”). As a participant attending the Festival (“Participant”), you acknowledge that you have fully read, understood, and agree to the following:

1. All Participants must (1) Register with Mystic Quarry and pay any Mystic Quarry fees due. (2) Check-in with Festival Organizers upon arrival.
2. All Participants must follow instructions from Festival Organizers and from Mystic Quarry personnel. Festival Organizers will be wearing name tags bearing Festival logo. Festival Organizers will be available to answer any questions concerning the Festival. Visit or call Mystic Quarry office for any general questions concerning Mystic Quarry or your stay.
3. All Participants over the age of 18 must complete, sign, and return to Festival Organizer the Participant Waiver and Release form (“Waiver”) prior to participating in the Festival. We ask the Participants to complete the Waiver electronically online prior to arrival by visiting the Festival Organizer website (*belfesttexas.com*). For those Participants who do not complete the Waiver online, the Festival Organizers will have hard copies available upon arrival.
4. Once the Participant submits completed and signed Waiver to Festival Organizers, Festival Organizers will provide the Participant with Festival wrist bands. Participants must wear these bands at all times while attending the Festival.
5. Participation in the Festival or any of its activities without submitting the requisite Waiver (electronic or hard copy) to Festival Organizers is strictly prohibited. Individuals who fail to submit the Waiver will be considered to be trespassing and will be asked to leave the Festival immediately.
6. If a Participant brings any minors (under the age of 18), the Participant agrees to: (a) list the name(s) of all such minor(s) who will be present at the Festival; (b) be personally responsible for the conduct of any such minor(s); (c) insure that any such minors follow all laws, regulations, and this Code of Conduct; and (d) indemnify and hold harmless the Organizers for any damage, liability or personal injury that may arise from the minor being on the Premises during the Festival, including, but not limited to, any harm to the minor or any harm that may be caused by the minor.
7. All Participants must abide by federal, state and local laws while at the Premises during the Festival.
8. No lewd, threatening or harassing behavior will be tolerated.
9. All participants must follow federal, state, and local health laws, regulations, and guidelines, including, but not limited to, those related to COVID virus. Participants acknowledge and assume all health risks associated with attending the Festival, including, but not limited to, potential exposure to COVID virus.
10. No firearms or weapons of any kind, licensed or unlicensed, are allowed at the Festival.
11. Participants must be respectful of the environment and not litter.
12. No underage alcohol consumption at the Premises during the Festival is allowed.
13. All Participants must follow Mystic Quarry’s after-hours noise policies.
14. Any advertising at the Festival requires prior written consent from the Organizers.

15. By bringing a pet onto the Premises during the Festival, pet owners agree to indemnify and hold harmless both the Festival Organizers and Mystic Quarry and its owners, against any and all damage, liability or personal injury that may arise from the pet being on the Premises.
16. Pets must be leashed and under control of their owners at all times while at the Festival. Specifically, pet owners may not leave pets unattended at any time while at the Festival. Pet owners are also responsible for securing their pets to ensure that the pets do not present a hazard to others. Additionally, all pets must be licensed, immunized, and otherwise comply with all applicable state and local regulations.
17. Failure to comply with any of the requirements listed in the Code of Conduct for the Festival may result in the Participant being asked to leave the Festival and/or the Premises, and may be subject to any applicable criminal penalties, including, but not limited to, arrest and criminal prosecution.
18. If you witness any behavior at the Festival that does not comply with the Code of Conduct, please notify one of the Festival Organizers. 409-422-7372. Furthermore, in case of emergency or if you witness any criminal activity or conduct that may otherwise endanger others, please call 911 for immediate help and also notify Mystic Quarry personnel.
